Power of Attorney

This power of attorney entitles the above-named holder

- 1. to conduct litigation on my behalf (including under Sections 81 ff. of the German Code of Civil Procedure) as well as to file and/or withdraw counterclaims.
2. to file petitions on my behalf in divorce cases and matters involving consequences of divorce, to conclude agreements on consequences of divorce, as well as to submit applications for access to information on retirement pensions and other types of pensions.
3. to represent and defend me in criminal cases and matters involving administrative fines (Sections 302, 374 of the German Code of Criminal Procedure), including in related preliminary proceedings, as well as (in my absence) to represent me under Section 411 II of the German Code of Criminal Procedure, with express authorization under Sections 233 I, 234 of the German Code of Criminal Procedure, as well as with express authorization to accept on my behalf writs, summonses, or subpoenas under Section 145 a II of the German Code of Criminal Procedure, to file on my behalf criminal complaints and other complaints permissible under the Code of Criminal Procedure, as well as to file on my behalf applications under the Compensation for Wrongful Prosecution Act, in particular in damage award proceedings.
4. to represent me in other proceedings and in any kind of extrajudicial negotiation (in particular in accident-related cases, in the assertion of claims against persons responsible for having caused damages, against registered vehicle owners and/or operators, as well as against their insurers).
5. to conclude and to terminate agreements as well as to submit and to accept unilateral declarations of intention on my behalf (e.g. notices of termination) in connection with the matter named in the above under "for . . .".

This power of attorney applies to all levels of jurisdiction and includes any kind of parallel and subsequent proceedings (e.g. arrests, temporary injunctions, cost setting, enforcement, intervention, forced sale, receivership, bailment, deposit, insolvency, or composition proceedings relating to the opponent's assets). It includes, in particular, the authority to have documents served and to accept service of documents, to transfer this power of attorney entirely or in part to other persons (delegated power of attorney), to file, revoke, or waive appeals or other legal remedies, to resolve litigation or extrajudicial negotiations on the basis of settlements, arrangements, compromises, conciliation, waivers, renunciations, disclaimers, relinquishments, or acknowledgements, to accept moneys, valuables, and documents, in particular such that are objects of litigation and any amounts that are to be paid out by the opposing side, the judicial cashier's office, or any other sources, as well as to inspect files and records.
